

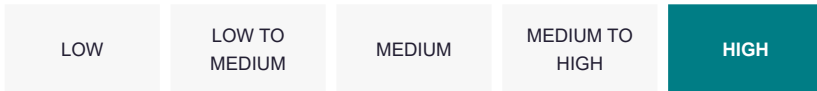


Equitable Life Dynamic Power Global Growth Fund

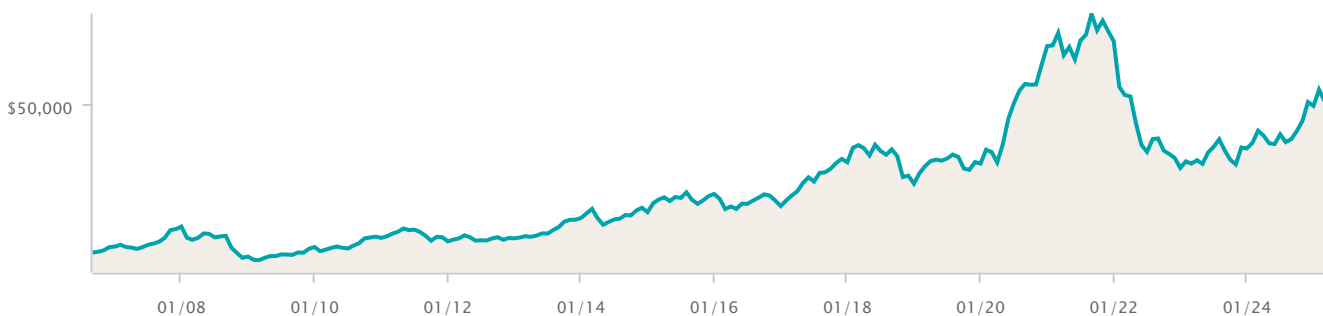

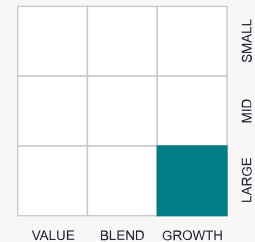
