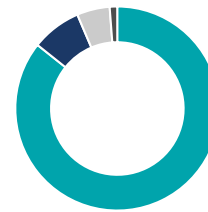

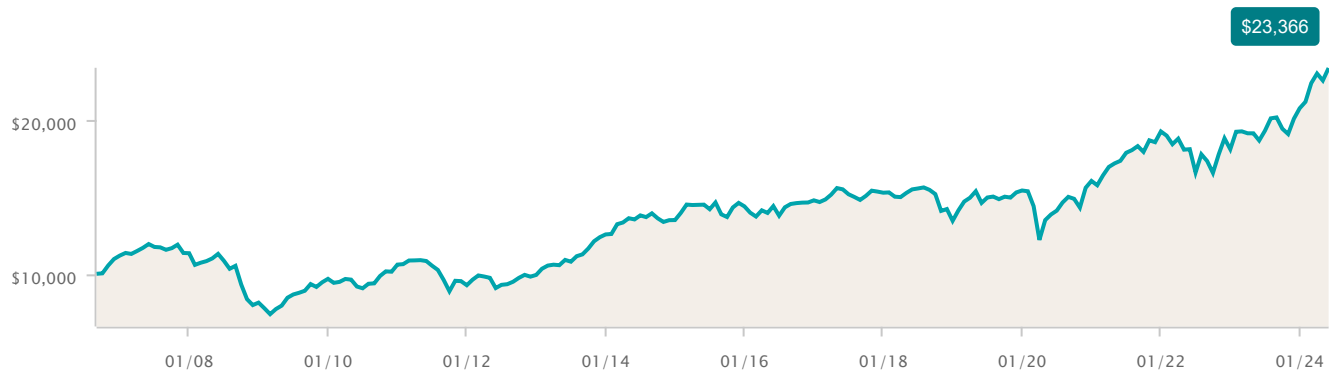
Geographic Allocation (%)

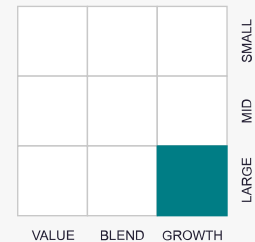
