The fund may from time to time invest in companies located in other countries, generally in the Mediterranean region.

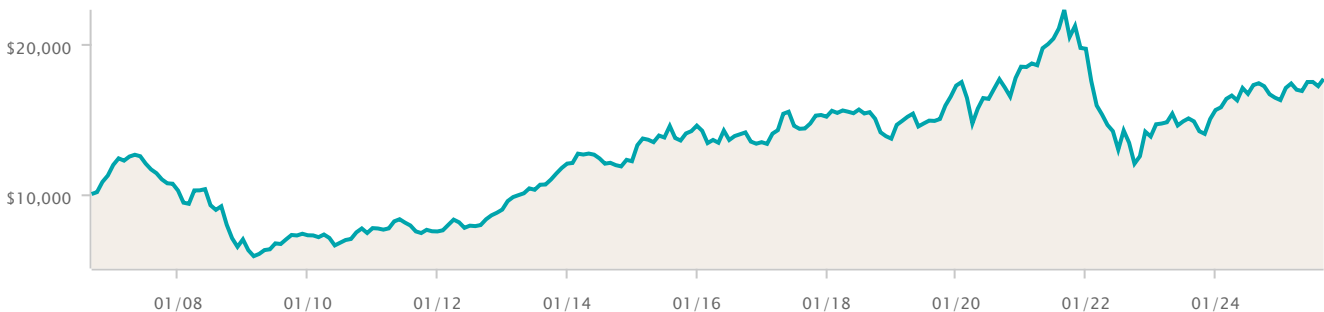
