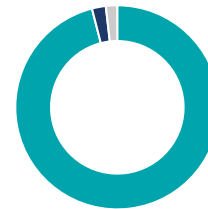

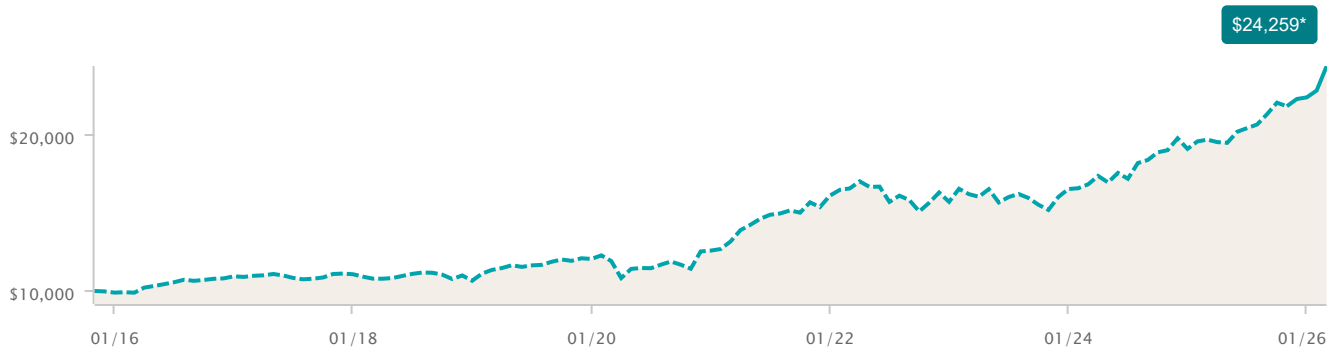
## Geographic Allocation (%)
