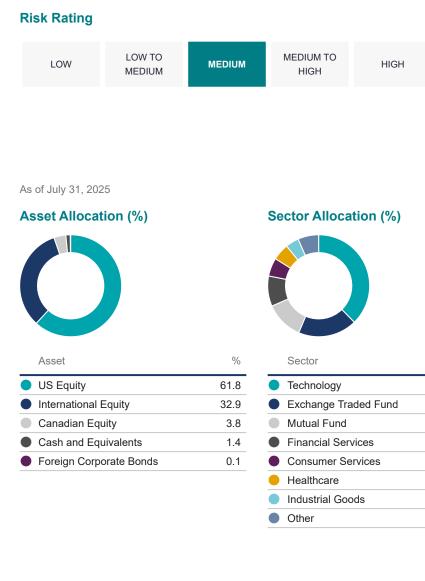


Equitable Life Quotential Diversified Equity Portfolio Select

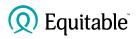
