


# Equitable Life Quotential Diversified Equity Portfolio

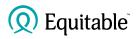
