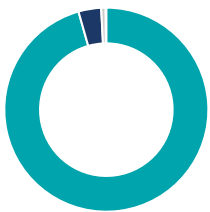

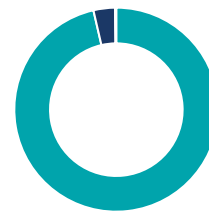

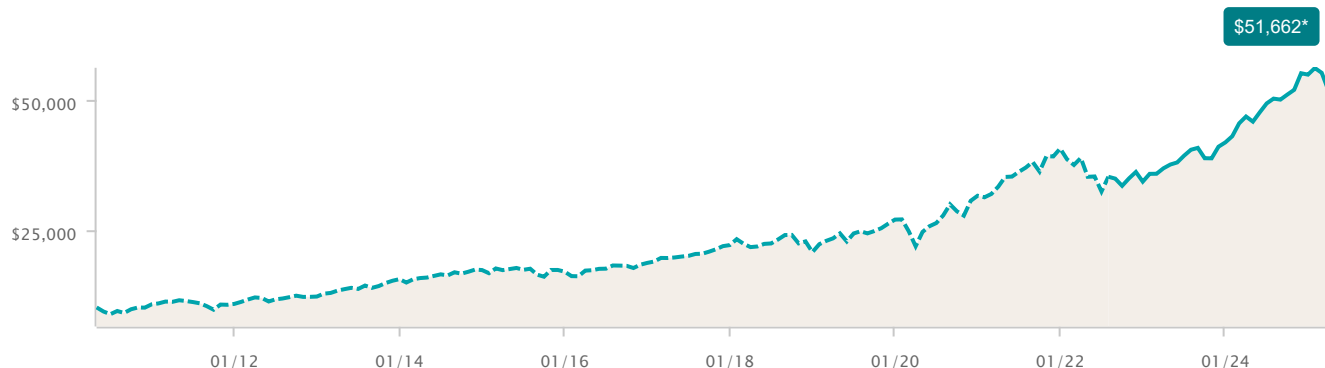
Geographic Allocation (%)
